THE LEGAL CLINIC THROUGH STAFF ATTORNEYS AS WELL AS VOLUNTEER LAWYERS AND PARALEGALS PROVIDED LOW-BARRIER, HIGH QUALITY, PRO BONO LEGAL HELP FOR PEOPLE EXPERIENCING HOMELESSNESS AND HOUSING INSECURITY. BECAUSE OF THE CONTINUING COVID-19 PUBLIC HEALTH EMERGENCY, THE LEGAL CLINIC CONTINUED ITS SUSPENSION OF IN-PERSON INTAKE SESSIONS. INSTEAD, INTAKE IS CONDUCTED VIA PHONE. THROUGHOUT 2022, WE CONDUCTED 144 INTAKE SESSIONS WHERE OUR VOLUNTEER ATTORNEYS OPENED 147 CASES. OUR STAFF ATTORNEYS ASSISTED AN ADDITIONAL 85 MATTERS.
