FOR LEGAL SERVICES IN 2024, THE LEGAL CLINIC HELD MANY WEEKLY INTAKE SESSIONS WHERE VOLUNTEER ATTORNEYS OPENED 253 CASES. STAFF ATTORNEYS OPENED AN ADDITIONAL 131 LEGAL MATTERS. OVERALL, 110 CASES WERE RELATED TO SHELTER ISSUES (A NUMBER OF WHICH FOCUSED ON SECURING ACCESS TO SHELTER FOR FAMILIES WHO HAD BEEN UNLAWFULLY DENIED ADMISSION TO THIS LIFE-SAVING RESOURCE) AND 236 CASES INVOLVED HOUSING ISSUES (OFTEN RELATED TO SHORT- AND LONG-TERM HOUSING SUBSIDIES). THE REMAINDER WAS A MIX OF ISSUES CONCERNING CASH BENEFITS AND CIVIL ISSUES THAT INCLUDED CONSUMER MATTERS, DISCRIMINATION, DISABILITY RIGHTS, POLICE CONDUCT, IDENTIFICATION, AND MORE.
